- Prompt Payment Discount** is an additive discount applicable to Direct Purchase invoices paid in full only and is available to Members that satisfy the following payment terms: 2% 60, net 61 ("Prompt Payment Discount"). Prompt Payment Discount, if applicable, is calculated from the Invoice Price after application of other Discounts and exclusive of current FET or other Taxes levied upon Product. Prompt Payment Discount shall be applied against the final net invoice price of each applicable Product after deduction of any Discounts Member is entitled to in accordance with the Agreement, as amended from time to time by Seqirus.
